## SHARING YOUR INFORMATION

We will not sell or exchange your personal information. We will only share your personal information where we are required to fulfil our contract with you, or legitimate interest, where we have your consent, or we are required to do so by law.

We may share your personal information with third party organisations who will process it on our behalf. This is strictly governed by data processing terms which confirms that the personal information we provide will only be used for the purposes we specify and will be processed in line with data protection legislation.

Other third parties we may share your personal data with include:

- Public bodies such as The Charity Commission, Inland Revenue, local councils or the
  police for the prevention and detection of crime or other competent authorities with
  investigations including criminal and safeguarding investigations. The legal basis in
  these cases is compliance with a legal obligation.
- In case of an emergency we may also share your information with the relevant public health and emergency services and contact your next of kin. The legal basis for processing in such cases is to protect your vital interests.

## INTERNATIONAL TRANSFERS

SFCT only operates in the UK, however some of our trusts have interests in the EEA and outside the EEA. Please refer to the corresponding trust privacy notice for further details.

SFCT works with many suppliers and it is possible that we will share your data with other third party suppliers that process your data in countries outside the UK where the data protection laws are not equivalent to those within the UK. Where this applies, we do so, either on the basis of an 'adequacy decision' or using Standard Contractual Clauses approved by the European Commission and recognised by the UK which contractually oblige companies in those countries to the standard expected within the UK. More information about these is available here.

## YOUR RIGHTS

The GDPR provides you with certain rights in relation to the processing of your personal data, including to:

Request access to personal data about you (commonly known as a "data subject
access request"). This enables you to receive a copy of the personal data we hold
about you, and to check that we are lawfully processing it.

- Request rectification, correction, or updating to any of the personal data that we hold about you. This enables you to have any incomplete or inaccurate information we hold about you corrected.
- Request personal data provided by you to be transferred in machine-readable format ("data portability").
- Request erasure of personal data. This enables you to ask us to delete or remove
  personal data where there is no good reason for us continuing to process it. You also
  have the right to ask us to delete or remove personal data where you have exercised
  your right to object to processing (see below).
- Request the restriction of processing of your personal data. This enables you to ask
  us to suspend the processing of personal data about you (e.g. if you want us to
  establish its accuracy or the reason for processing it).
- Object to the processing of your personal data in certain circumstances. This right may apply where the processing of your personal data is based on the legitimate interests of SFCT.

These rights are not absolute and are subject to various conditions under applicable data protection and privacy legislation and the laws and regulations to which we are subject.

If at any time you decide that you no longer wish to be contacted for marketing purposes, or if you would like to exercise any of your rights as set out above, you can contact us by email. See 'Contact Us'.

You will not have to pay a fee to access your personal data (or to exercise any of the other rights). However, we may charge a reasonable fee if your request for access is clearly unfounded or excessive. Alternatively, we may refuse to comply with the request in such circumstances.

In addition to the above, please note that you have the right to make a complaint at any time to the <u>Information Commissioner's Office</u> if you are concerned about the way in which we are handling your personal data.

## DATA RETENTION PERIOD

THE SAINSBURY FAMILY CHARITABLE TRUSTS

We will retain your personal data for as long as it necessary for the purpose of our relationship or until you object to us processing it or withdraw your consent. Where CCTV is operational, we retain recordings for no less than 28 days and no more than 31 days on a rolling basis.
